## **SEX OFFENDER INFORMATION BULLETIN**

The Fond du Lac County Sheriff's Office is releasing the following information pursuant to Wisconsin State Statute 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release when, in the discretion of the agency, the release of information will enhance public safety, awareness and protection. The individual who appears on this notification has been convicted of a sex offense. **Further, his criminal history places him in a classification level which reflects the potential to re-offend.**

This sex offender **has served** the sentence imposed on him by the courts. **He is NOT wanted by the police at this time.** This notification is not intended to increase fear; rather, ***it is our belief that an informed public is a safer public.***

Sex offenders **have always** lived in our communities; but it was not until the Sex Offender Registration and Community Notification Law was enacted that law enforcement was able to share this information with the community. **Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will NOT be tolerated.**

On 03/10/00 in Fond du Lac County, Mr. Broeders was convicted of 2<sup>nd</sup> Degree Sexual Assault of a Child. His victim was a 14 yr old female acquaintance and he provided her marijuana prior to the assault. Mr. Broeders was sentenced to 5 yrs prison. On 11/29/04 again in Fond du Lac County, Mr. Broeders was convicted of 4<sup>th</sup> Degree Sexual Assault. The victim was a 13 year old female acquaintance and force was used. He was sentenced to 9 months jail. His parole in the 2000 conviction was also revoked and he was returned to prison.

Prior to his scheduled release from prison in 2007, the State of Wisconsin pursued and was successful in the civil commitment of Mr. Broeders under the Chapter 980 Sexually Violent Persons Law. Mr. Broeders was civilly committed on 8/29/07 and has been at a secure facility since that time. A recent court review has determined that Mr. Broeders meets the criteria for supervised release.

Pursuant to the court approved supervision plan, Mr. Broeders must be released prior to 5/1/15 and will reside at **N8578 Nitschke Rd, Van Dyne WI 54979**. He will be supervised by the Department of Health Services and the Department of Corrections by agents who specialize in the supervision of sex offenders. Specialized rules and restrictions include the following...

- Comply with standard sex offender rules including but not limited to: no contact with victims; no unsupervised/unapproved contact with minors; no taverns/bars/liquor stores; no alcohol/drug use.
- Cooperate with offense related programming.
- No visitors to the residence without prior approval
- In accordance with state statute, is not allowed to leave his residence unless under direct staff supervision for the first year.
- Lifetime Sex Offender Registration and lifetime GPS monitoring.

Mr. Broeders will remain under supervised release for an indefinite period of time. Discharge for any offender from Chapter 980 supervised release must be authorized by the court when it is determined the offender no longer meets the criteria for commitment or supervised release.
